### TERMS & CONDITIONS

**OPERATION:** Flea Market is open every Sunday until the season ends, rain or shine. Cancelled only in the event of a major storm. Vendor entry, payment, and set-up time starts at 6:00am. Vendors must vacate the field by 5:00pm.

**SPACE RENTAL:** One vendor space equals two drive-in spaces (approx. 18' x 18') and costs \$25 for the day. A double vendor space (approx. 18' x 36') is available and costs \$40 for the day. Cash Only. There are no refunds. The use of tents and/or tarps is allowed and must be securely staked or tied down with appropriate sized rope, not bungee cords. Please occupy only the space you rented and do not spill over into another vendor's space.

**PARKING:** Each vendor is allowed one vehicle in the rented space. Two vehicles are allowed in a double space. Additional vehicles require the purchase of an additional vendor space. Please keep walkways open for foot traffic.

**SALES TAX:** The collection and remittance of NYS sales taxes is the sole responsibility of each vendor. The combined NYS & Rensselaer county rate is 8%. A copy of your valid certificate of authority must be submitted with this registration form. Please post your sales tax certificate of authority in your space.

**INSURANCE:** Each vendor is responsible for obtaining and having in force adequate & necessary insurance covering their automobile and any other insurable interest they may have. By signing this registration form you agree to hold harmless Hathaway's Drive-In Theatre, its owners, agents, and assigns for any and all actions of yourself, other vendors, or the public at large that occur while on the property.

**WASTE:** Vendors must not leave behind any unsold, damaged, or unwanted merchandise. All trash, boxes, bags, food waste etc. that you brought to the field from home must leave with you. Only food related trash from Hathaway's snack bar may be disposed in the barrels located in the building.

**ANIMALS/PETS:** All pets must be caged or leashed and quiet at all times. Pets are the sole responsibility of the owner/vendor and must be cared for and cleaned up after. Pets are not allowed in the snack bar or restrooms unless they are registered as service animals to assist a blind or handicapped individual, and clearly identified as such.

**GENERATORS:** The operation of generators is prohibited during the flea market hours of 8:00am-3:00pm.

**RADIOS/MUSIC:** Please operate radios and other entertainment devices at levels that do not disturb other vendors or the general public.

**RESTRICTIONS:** We reserve the right to deny entry to, and/or remove, any vendor selling products that are illegal, fraudulent, or deemed inappropriate by the management of this flea market. Merchandise that requires special licensing or copyrights by State or Federal Governments is prohibited.
